

# BOARD OF TRUSTEES APPROVES TO CONTINUE SCBA CLE PASSPORT PROGRAM FOR 2018-2019

**COST: \$275** - Less than three seminars at regular member rates!

Attend any number of SCBA sponsored seminars in their entirety or any segment thereof throughout the SCBA's fiscal year (September 1, 2018 through August 31, 2019). Your 2018-2019 SCBA Membership Dues must be paid prior to or at the time of payment of the Annual CLE Passport.

**PLEASE NOTE: The Spokane County Bar Association does not normally sponsor CLE seminars in July and August due to typically low attendance rates during these months.**

Seminars sponsored in conjunction with any other entity are not applicable under this payment system, such as GAL Training, YLD programs, sections etc. This fee also does not apply to Bar Luncheons or A/V CLE materials.

You may opt to pay for the CLE Passport at any time throughout the 2018-2019 Bar Year. However, previously paid CLE fees cannot be applied towards the CLE Passport Fee, unless otherwise noted. Refunds are not allowed.

**You must still pre-register for all seminars.** In order to provide adequate number of written materials and refreshments we need an accurate number of attendees, so please pre-register whenever possible. **PLEASE REMEMBER TO INCLUDE YOUR WSBA # WHEN REGISTERING TO ENSURE ACCURATE CREDIT REPORTING.**
