SPEAKER BIOGRAPHIES

PAT DONAHUE - Based out of Spokane, Washington Pat Donahue primarily represents criminal clients in Eastern Washington and Northern Idaho. Pat is an avid outdoorsman, and enjoys taking full advantage of all the Inland Northwest has to offer. Outside the classrooms of Gonzaga, Pat's legal career began as Rule 9 Licensed Legal Intern during the late summer and fall of 2013 representing clients in Spokane County's Drug Court (one of the first drug courts in the county). During the winter and spring of 2013-2014, Pat carried a misdemeanor caseload for the Spokane County Public Defenders. Pat was admitted to the Washington State Bar in September of 2014. After a brief stint in civil litigation, Pat followed his passion for defense work and in late April of 2016 set out on his own by founding Donahue Law.

While Donahue Law continues to defend the accused by representing criminal defendants in state courts, beginning in late 2020 Pat began to shift the focus of his practice towards legal psychedelics. In early 2021, Pat became one of the initial members of the Psychedelic Bar Association (PBA). The PBA is an association of accomplished attorneys dedicated to solving the novel legal and policy issues impacting the emerging psychedelics sector.

FRANK CIKUTOVICH Frank Cikutovich is a no-holds barred kind of lawyer, with special expertise in defending drug crimes. In eastern-Washington Frank has defended those accused of being high-profile drug dealers, Canadian pot growers and distributors, drug cartels, kidnapers, outlaw bikers, murderers and even little old ladies needing marijuana for medicinal reasons.
