SPEAKER BIOS

JUDGE RACHELLE ANDERSON was appointed to Superior Court Dept. 12 in January 2019, prior to that, she served as a Spokane County Superior Court Commissioner since December 2010. Judge Anderson spent 13 years in private practice, focusing on family law and juvenile dependency matters. She spent a brief time as an Administrative Law Judge with the Washington State Office of Administrative hearings before her time on the bench.

Professional Affiliations: Judge Anderson currently serves as Immediate Past-President of the Superior Court Judges Association and is Co-Chair of the Superior Court Judges Association Legislative Committee. She serves on the SCJA Guardianship and Probate Committee, which she formerly chaired. She is former Chair of the Certified Professional Guardianship Board, former Chair of the WSBA Character and Fitness Board, and former Washington Young Lawyer Division Trustee.

WILLIAM C. DODGE, Administrative Law Judge, Pro Tem (Ret.), CAPT, USN (Ret.)

Bill graduated from Gonzaga School of Law in 1980 and then served on active duty in the Navy as a JAG until 1984. He remained in the Navy Reserves until he retired in 2008 as a Captain (O6) after consecutive tours as Commanding Officer of Navy Reserve Intelligence units. He has served as a Special Assistant United States Attorney (SAUSA) and an Assistant Attorney General (AAG). Bill has most recently served as an Administrative Law Judge (ALJ) for the Washington State Office of Administrative Hearings (OAH), conducting hearings for several different agency caseloads. Bill served as an Assistant Deputy Chief to the Chief Administrative Law Judge (agency director) in his final 4 ½ years with OAH. Although he retired in 2014 Bill continued to work as a Pro Tem ALJ conducting hearings and working directly for the Chief ALJ on special projects through 2020.

Bill has been a CLE presenter for the King County Bar Association at its annual mandatory GAL training. He also presented a CLE on Suitable Representation at the 2019 October Legal Lunchbox™ Series for the Washington State Bar Association.

Bill has served as a GAL/Court Visitor in Spokane County for over 30 years and has been a presenter at numerous previous training sessions for new GAL candidates since 2006 as well at the annual mandatory training for GALs on the Spokane County registry. Bill speaks to parents affiliated with the Down Syndrome Connections Network about guardianship options for their children when they reach 18 and has assisted a graduate student in a video for her thesis: Supported Decision Making. He received the GAL of the Year award from Spokane County for his Pro Bono work in a case involving the parents (Petitioners) of a US Army Soldier who was critically wounded in an IED attack in Iraq. For those efforts he also received the Random Acts of Professionalism from the Washington State Bar Association.

CATHERINE KARDONG - Catherine graduated first in her class from Gonzaga University School of Law and began her legal career at the Washington State Supreme Court, where she clerked for Washington Supreme Court Justice Mary E. Fairhurst. She was then selected as an honors candidate at the Washington State Attorney General's Office and spent two years in Olympia representing areas within the Department of Social and Health Services that serve the aging and disabled populations of Washington. Catherine and her family relocated to Spokane where she continued on with the Attorney

General's Office and began representing various institutions of higher education, most recently acting as lead counsel for Eastern Washington University.

Catherine is originally from Spokane, having graduated from Lewis and Clark High School before venturing to the east coast to earn her undergraduate degree from Boston College. During law school, she was a Thomas More Scholar and a member of the Gonzaga Law Review. She also clerked for United States District Court Judge Robert H. Whaley and United States Bankruptcy Judge John A. Rossmeissl. She was admitted into practice in Washington in January of 2014.

KELLY B. MOORE has spent most of the last 30+ years in social services with a primary focus on people with developmental disabilities. Her roles have been a care provider, case manager, quality assurance manager, human resource coordinator, trainer, trouble-shooter, supervisor, advisor and advocate. She has developed classes, trained and consulted in a variety of arenas in the social services for ADSA, DSHS, DDA, ALTCEW and at times participated in training new Guardians ad Litem, now known as Court Visitors. Kelly has been a Certified Professional Guardian since 2006 and conducting business as Office of Public Guardian and as a sole proprietor of Moore Guardianship Services since 2012 working with people with developmental disabilities, aging and mental health issues. She has spent many years developing, implementing and monitoring person centered plans, positive behavioral support and developing effective and responsible teams.
