CLASSIFIED ADS

A "line" is 7" in length and based on a size 12 Times New Roman font. Classified ads appear on the last page of each issue.

<u>COMMERCIAL ADVERTISEMENTS</u> - **\$17.00 per line**. Types of commercial ads include ads for business services, commercial properties, sales and lease of properties, nonmember attorneys, etc. **All commercial ads must be pre-paid!**

<u>ATTORNEY EMPLOYMENT ADVERTISEMENTS</u> - **\$12.00 per line**. Types of attorney employment ads include ads placed by attorneys looking for employment or attorneys or firms seeking to hire attorneys or attorney services for their office/firm. **Lawyers or law firms placing these ads, must be a member of the SCBA to qualify for this rate, otherwise the commercial rate applies.**

<u>LEGAL ADVERTISEMENTS</u> - **\$10.00 per line**. Legal advertisements include ads placed by attorneys or law firms seeking to employ non-attorney staff, office sharing or office space available for rent, legal support staff seeking employment, etc. **Lawyers or law firms placing these ads, must be a member of the SCBA to qualify for this rate, otherwise the commercial rate applies.**

<u>BLIND ADS</u> - **\$25.00 per ad run**. If you are posting a blind employment ad, text similar to that below will be added to the end of the classified ad and will ad to the cost of the classified ad.

FULL PAGE ADS - 7.5" W X 10" H

One Page

- Member price \$250
- Nonmember price \$275

Two Pages

- Member price \$350
- Nonmember price \$375

PROMINENT POSITION UPGRADE - Display Ads

Front Page placement - $\frac{1}{4}$ page ads only accepted on the front page - add \$200 to cost of ad Page 2 placement - $\frac{1}{4}$ page ads only accepted on Page 2 - add \$150 to the cost of the ad

Page 3 placement - add \$100 to the cost of the ad

Page 4 placement - add \$75 to the cost of the ad

Images should be set to print resolution (600 dpi)

Find your print size: [resolution]/300 dpi = print size in inches.

example: a 1200x1800 resolution image will give you a high quality 4x6 print.

1200/300 = 4 inches and 1800/300 = 6 inches

When working with images and photographs, quality counts.

For shooting quality portrait photos use this chart to ensure your photos are print resolution worthy.
