#### **U.S. Attorney Announces Anti-Hate Crime Initiatives**

U.S. Attorney Commits Additional Resources to Civil Rights Cases and Outreach Launches Web Page for Civil Rights Information and Complaints

Waldref. "We are increasing our focus on civil rights, including hate crimes, hate incidents, and illegal discrimination, by committing additional Assistant U.S. Attorney and staff resources. We are deploying these increased resources in the area of civil rights - such as vigorously enforcing the Americans with Disabilities Act (ADA), the Fair Housing Act, as well as veterans and active service members rights, to name just a few," said U.S. Attorney Waldref.

"We cannot bring the full force of the people's power against hate crimes, hate incidents, and other civil rights violations without individuals being given opportunities to come forward. Our office now has a dedicated civil rights email account (<u>USAWAE.CivilRights@usdoj.gov</u>) and phone number ((509) 835-6306), for the public's use. I want to thank the Gonzaga University Department of Modern Languages and Literature who donated their expertise to this effort and provided Spanish translation services to allow us to reach a wider audience and facilitate access to these accounts for Spanish speakers. These accounts are monitored frequently and will allow members of my civil rights team to quickly review and promptly respond to submissions and inquiries. We will utilize the information provided by the public regarding suspected civil rights violations in our overall efforts to track and analyze any larger trends that need to be addressed and to determine on a case-by-case basis whether we can investigate the matter, refer it to other appropriate entities, or otherwise assist," said U.S. Attorney Waldref.
